## Royal Decree

### State Charter of ShaKori AyeliUdotlvsv YiSrael, MeToac MonaTona Territory, Nu Jeruz, Azareth: north America

**K**NOW ALL YE THESE PRESENTS, On this 21<sup>ST</sup> Day of the 8<sup>TH</sup> Month in the Year of our Ah'Ba Na'Wa Ha'WaH, 2015, the CREATOR over all creation and Alahym of the Ancient Israelites, from whence we, the Sha'Koris descend, in HIS immutable sovereignty and on the isles of the birth place our ancient ones first inhabited—since time immemorial, as scribed in 2 Nephi 1, by and through the resurrected and repatriated Sha'Kori Ywvi,<sup>i</sup> hand of bloodline descendant KaSiKa ShâBî CādōChé YaShar'al, in unison with Sha'kori Za'Qans; To Wit: the Sha'Kori AyeliUdotlvsv Yi'Srael Tza'rTer Ba'Tach Chatham with all immutable ordained rights, as recognized in the inviolable International Law Doctrine of Reversion;<sup>ii</sup> Therewith, Declare, Decree, and Proclaim the birth of The Ibaryath Abar'Rishoni American Indian (as currently defined in man's law) Montevideo Convention Treaty Nation-State<sup>iii</sup> to be known henceforth as, The Sha'Kori AyeliUdotlvsv Yi'Srael, Metòac, MönaTon Nu Jeruz, Azareth:<sup>iv</sup> North America; without the United States;<sup>v</sup> having immutable "natural law" sovereignty as preordained by our Creator, as well irrefutable plenary protection under "man's law" Foreign Sovereign Immunities Act "Peremptory Norm" Non Derogable Jus Cogens International Law—being predetermined it cannot be derogated from by Treaty, Protest, or Acquiescence; Therewith, NOT beholden to the United States Corporation,<sup>vi</sup> its entities, agencies, and/or instrumentalities, et. al., statutes, codes, regulations, et.al; To Wit: The Sha'Kori AyeliUdotlvsv Yi'Srael, Metòac, MönaTon Nu Jeruz, Azareth: North America, its Citizenry and lawful extensions are forever immune from the jurisdiction of the United States courts<sup>vii</sup> and all its attachments; having international recognition as a sovereign state with a defined territory without the United States, an appointed KaSiKa TzēDaKaH— consecrated unto our CREATOR; Thereto, equality in sovereignty with the 50 Republic States, et. al., of The united States of America; Taking oath to renew our ancestral covenant and birthright; obeying the creator's laws, forever subjected under the immutable dominion, authority and power of Ah'Ba Nawa Ha'WaH whom alone hath Repatriated The Sha'Kori AyeliUdotlvsv Yi'Srael, Metòac, MönaTon Nu Jeruz, Azareth: North America Ancestral Lands; having both judicial and jurisdictional sovereignty over the fourth part of the earth ancestral lands commonly known as the united States of America, as long as HIS Chosen Elect change not their creator for a no g-d, remaining true to HIS Covenant; Accordingly, Sha'Kori AyeliUdotlvsv Yi'Srael Tza'rTer Ba'Tach Chatham and the Sha'Kori AyeliUdotlvsv Yi'Srael, Metòac, MönaTon Nu Jeruz, Azareth: North America are perpetual; being authorized and empowered to do all things needful, necessary and proper for the sustainable development of its Peoples and sovereign KINGDOM government.
